Article 1 Subject

1.1 The subject of the contract shall be the Supply of one (1) vehicle through financial leasing.

The subject of the contract shall be the supply of one (1) new SUV vehicle through financial leasing for xx months in everything according to the Annex II + III - Technical specification + Technical offer specification and Financial offer of the Contractor.

With this Contract, the contracting authority is authorized by the Contractor to hold and use one (1) SUV vehicle as an object of leasing.

The object of leasing is:

- One (1) SUV vehicle brand _____, type _____, produced in _____ year, by the producer _____.

The time limits for delivery shall be 30 calendar days from date of signing this Contract.

The Incoterm applicable shall be DDP⁴.

The place of acceptance of the supplies shall be at the premises of the Cantonal Public Institution for the Protected Natural Areas, Branilaca Sarajeva 28/1, 71000 Sarajevo, Bosnia and Herzegovina.

Upon taking over the subject of leasing, contracting authority and contractor will sign The certificate of provisional acceptance.

1.2 The contractor shall comply strictly with the terms of the special conditions and the technical annex.

1.3 [The supplies which form the [subject of the contract] must be accompanied by the spare parts described by the contractor in its tender] [and by the accessories and other items necessary for using the goods over a period of period of 3 years for items 2 and 3 / 2 years for item 1 as specified in the instructions to tenderers].

Article 2 Origin

The rules of origin of the goods are defined in Article 10 of the special conditions.

A certificate of origin for the goods must be provided by the contractor at the latest when it requests provisional acceptance of the goods. Failure to comply with this condition may result in the termination of the contract and/or suspension of payment.

Article 3 Price

3.1 The price of the supplies shall be that shown on the financial offer (specimen in Annex IV).

The total maximum contract price of the object of leasing shall be BAM 13000.

The total maximum contract price of the object of financial leasing shall be BAM 20 000.

The total maximum monthly rate shall be (determined by the offer) 4.333,3 BAM .

3.2 Payments shall be made in accordance with the general and/or special conditions (Articles 26 to 28).

Article 4 Order of precedence of contract documents

The contract is made up of the following documents, in order of precedence:

- the contract agreement;
- the special conditions
- the general conditions (Annex C.I);
- the technical specifications (Annex C.II. [including clarifications before the deadline for submission of tenders and minutes from the information meeting/site visit];
- the technical offer (Annex D [including clarifications from the tenderer provided during tender evaluation]);
- the budget breakdown (Annex C.III);

The various documents making up the contract shall be deemed to be mutually explanatory; in cases of ambiguity or divergence, they shall prevail in the order in which they appear above.

Article 5 Other specific conditions applying to the contract
